As per the order of Dept. of Health and Family Welfare, Govt. of west Bengal Vide Memo No. HPH/NTCP-COTPA/LAW/2014/5278 dated 7th August, 2015; you are also requested to constitute an Enforcement Squad at Block Level with the members as mentioned in the Annexure -III within 31st October, 2015.

The terms of reference of the enforcement squad are the following:-

- 1. Weekly /fortnightly Raid.
- 2. Place of Start It might be Police Station or BPHC /RH.
- 3. Vehicle to be provided by the Health Department.
- 4. At least 3 members together for any raid.
- 5. Representatives of the members of the Enforcement Squad can be there.
- 6. From Police Not bellow the rank of Sub-inspector is a must.
- 7. Reporting of Raids every month to District Nodal Officer, (Dy. CMOH II) Bankura.
