Resolution of the meeting of the District Level Co-ordination Committee, Bankura (DLCC) for Cigarette & other Tobacco Products Act (COTPA) will be held on 27.07.2015 (Monday) at 10.15 a.m in the Circuit House, Bankura

The District Magistrate, Bankura took the chair & welcomed all the members present and initiated agendawise discussion.

At first Mr. Nirmalya Mukherjee, Director Planning, MANT, Kolkata & Mrs. Papia Sen, Executive Director, MANT Kolkata briefly discuss about the COTPA Act and bad effects of Cigarette smoking & other tobacco products. For implementation of the programme successfully in the district and to declare Bankura district as a "Smoke Free" district they stressed the need for joint co-operation with District Aministration, District Health Officers, other District Level Officers, Municipalities and Panthayati Raj Institutions of the district. They also stressed for forming enforcement squad with the assistance of Police administration to implement Section 3 of COTPA and make success to declare the district as "Tobacco free & Smoke free."

Then CMOH, Bankura discussed about the different activities to be undertaken for implementation of the said act. After thorough discussion the following resolutions have been adopted unanonimously in the meeting.

- 2. Awareness campaign regarding the bad effects of Cigarette smoking & other tobacco products to be organised in all Educational Institutions, Health Units, College & School Hostels, Abasik Ashrams & in the slum areas and in the areas where the people live in backward areas and are socio-economically poor.
- Action: Dy. CMOH-II, Bankura, D.I. (Secondary & Primary), Bankura.

 3. "No Smoking" signage board and also signage boards specified health warnings on all tobacco products will be displayed in the entrance & in all floors of all offices of the district. The land line Telephone nos. of the respective officers should be written in the signage boards.

 Action: O.C. (Health), Bankura & MANT
- 4. All district level officers of various Line Departments of this district to be communicated regarding implementation of COTPA Act in their respective Office premises. Action: O.C. (Health), Bankura
- 5. As per Government Order, Block Level Co-ordination Committee (BLCC) would be formed in every block of this district.

 Action: BMOH of All BPHC, Bankura
- 6. A directives would be circulated to all the Schools and Colleges of this district to be declared smoke free and to remove / banned, all kind of advertisement about Cigeratte & other tobacco products within 100 yrds of the institution. A meeting with all head of the schools & colleges to be organized Sub-division wise for better achievements.

 Action: O.C (Health), Bankura
- 7. Identification and nomination of nodal officers by all the departments to be made. A formal request letter would be sent to all concerned. The Executive Officers in the Municipalities, Dy. CMOH-II, Bankura in the combined establishment of the CMOH and O.C. Health in the District Collectorate would act as Nodal Officer in their respective offices.

 Action: O.C. (Health), Bankura & Executive Officer of 3 Municipalities, Bankura
- 10. The Officer-in-charge of every Block Police Station & Thana shall be nominated as a member of Block Level Co-ordination Committee (BLCC). Action: All three ACMOHs, Bankura, Bishnupur & Khatra & BMOH, all BPHC, Bankura.
- 11. The meeting of District Level Monitoring Committee & District Level Co-ordination Committee will be held jointly in the same day.

 Action: Dy. CMOH-II, Bankura
