**Sub:** Enforcement of extant provisions on obtaining license for using premises for non-residential purposes for storing, packing, pressing, cleansing tobacco or preparing or manufacturing by any process whatsoever any product from tobacco.

Sir,

I am directed to request you to arrange to compliance with the extant provisions of section 201 regarding license to be obtained for use of premises for non-residential purposes in respect of item No.139 of Schedule II of the West Bengal Municipal Act, 1993 regarding use of any non-residential premises for storing, packing, pressing, cleansing tobacco (including snuff, cigar, cigarette and bidi) or manufacturing by any process whatsoever from tobacco within the Municipal area. The provisions of Section 201 and item No.139 of Schedule II of the West Bengal Municipal Act, 1993 are as follows:

***“201. License to be obtained for use of premises for non-residential purposes. – (1) No person shall use or permit to be used any premises for any of the non-residential purposes as mentioned in Schedule II without or otherwise than in any conformity with a license granted by the Chairman in this behalf on such terms and conditions as may be determined by regulations.***

***(2) The Board of Councillors shall determine by regulations a scale of fee to be paid for the issue of license in respect of premises used for non-residential purposes under sub-section (1) :***

***Provided that no such fee shall exceed five hundred rupees per month in respect of any premises.”***

***“SCHEDULE II (See section 201)***

***Purposes for which premises may not be used without a license or written permission***

*139. Tobacco (including snuff, cigar, cigarette and bidi) – storing, packing, pressing, cleansing, preparing or manufacturing by any process whatsoever.”*
