## Sub: Tobacco Free Office premises under the jurisdiction of South 24 Parganas and

## **Diamond Harbour Health District**

The Cigarette and Other Tobacco Products (Prohibition of Advertisement and regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (COTPA) was enacted in May 2003 essentially to discourage the consumption of Cigarette and other tobacco products and to protect youth and the general population from the harmful effects of tobacco use.

Section 4 of COTPA prohibits smoking in public places. Health care facilities and all the Government offices are defined as 'Public place' under COTPA and are to comply with the provisions of Section 4 of COTPA.

The Health and Family Welfare Department is committed towards improving health of the people as well as implementation of the tobacco control legislation. Promoting Tobacco free facilities and offices is an initiative towards this. In order to ensure the tobacco free facilities and offices, it is reiterated that the following steps to be taken by your respective end;

- 1. Display of "No Smoking Area" Signage at the entrance and additionally displaying at every entrance, every floor in addition to other conspicuous places in all the Government facilities. (The specification of signage is enclosed).
- 2. The signages must be in English, Hindi or in Bengali.
- 3. Display the name of the person at just below the signage to whom a complaint may be made, if necessary.
- 4. Ensure that smoking aids like ashtrays or lighters (used for smoking purpose) are removed found in the offices. Designated smoking rooms or zones are NOT PERMISSIBLE.
- 5. Ensure that nobody (staff, patients or visitors or any other person) use any form of tobacco (smoking or smokeless) in the whole campus including canteen and toilets.
- 6. Ensure that no tobacco products are being sold or offered in the whole campus including in the canteen and toilets.

- 7. Ensure random checking at the probable points of violation especially during the peak hours.
- 8. It is further added, that under COTPA, the head of Institution or any designated person on his/ her behalf is authorised to fine a person for an amount up to Rs. 200/- for violation Section 4 of COTPA in the facility or the office including canteen and toilets. (Challan and Receipt copy including head of account for deposition of fine is enclosed).
- 9. Fixation of District, Block and GP Level (if any) nodal officer in all the line department offices under the jurisdiction of South 24 Parganas and Diamond Harbour Health District to ensure the tobacco control activities. The primary responsibility of the Nodal Officer is to report the violation to the appropriate authorities or Enforcement Squad. The reports of violations may also be collated and recorded for the future planning and evaluation purpose.

The Nodal Officer is also responsible for Coordination of COTPA enforcement initiatives with other line departments. It is to be noted that only the designated officers or their representatives as mentioned in the law and its subsequent rule published on 15<sup>th</sup> September 2009 can impose fine on the violators.

- 10. Necessary circulars to make compliance to COTPA, 2003 mandatory under your jurisdiction.
- 11. The Notification of District Level Coordination Committee (DLCC), District level Enforcement Squad and District Level Monitoring Committee (DLMC) under National Tobacco Control Programme is attached herewith for your kind information.

Eliminating the violations, complying with the law by promoting Tobacco free facilities and offices is a specific responsibility of the Head of the Institution. Please ensure compliance.
