This has reference to the letter cited above, wherein, the Commissioner of Health and Family Welfare has informed that the Commissioner of Food Safety has prohibited the manufacture, storage, distribution, sale of Gutka/Panmasala by whatever name it is called which contains tobacco and nicotine as ingredients in the entire State of Andhra Pradesh for a period of one year with effect from 10-01-2013.

In this regard, the Principals of all the Government/ Aided/ Private unaided Polytechnics/ 2nd shift polytechnics in existing Engineering colleges/ D.Pharmacy Institutions are instructed to keep strict vigil and not to allow the sale/distribution of Gutka/Panmasala by whatever name it is called in and around the premises of Colleges/canteens for effective enforcement of the prohibition in the State.

The Regional Joint Directors of Technical Education, Hyderabad, Kakinada, & Tirupathi are herewith requested to ensure compliance of the instructions issued herein by the Institutions under their respective jurisdiction. Encl: As above.

Sub: Food Safety and Standards Act, 2006- imposition of prohibition on manufacture, storage, distribution, Gutka / Panmasala in the entire state of Andhra Pradesh- Regd.

Ref: 1 G.O.Ms. No. 6 dated 09-01-2013 of the Chief Secretary, Govt of Andhra Pradesh Hyderabad 2 Order No. 1508/F1/2012-13 Dated: 10-01-2013

Government of India has enacted integrated Food Safety and Standards Act 2006, (FSSA) by repealing the various existing food laws/orders to regulate and monitor the manufacture, process, pack, transport, store, distribute, sell and import of any food or food ingredient, so as to ensure availability of safe and wholesome food for human consumption and also to laying down science based standards. FSS Regulations 2011 were notified under the said act.

As per Regulation 2.3.4 of FSS (Prohibition and Restriction on sales) Regulations 2011, Tobacco and Nicotine shall not be used as ingredients in any food products. The Honorable Supreme Court held that Gutka is a food product in the case of Godawat's pan masala products pvt ltd & others Vs. Union of India.

Scientific studies (ICMR and NIHFW) reveal that Gutkha, Pan Masala contain tobacco, nicotine as ingredients and consumption of such products is injurious to health.

In exercise of the powers under section 30 (2) (a) of Food Safety and Standards Act 2006 read with 2.3.4 of Food Safety and Standards (Prohibition and Restriction on sales) Regulation 2011 and in the interest of public health, the Commissioner of Food Safety has prohibited the manufacture, storage, distribution, sale of Gutka / Panmasla by whatever name it is called which contains tobacco and nicotine as ingredients in the entire state of Andhra Pradesh for a period of one year with effect from 10-01-2013 vide order No. 1508/F1/2012-2013

All the Designated officers in the state with the assistance of Food Safety officers of their respective area are entrusted with the responsibility of implementation of the said prohibition order.

I request you to issue suitable instructions to all the Principals of Colleges under your jurisdiction to keep strict vigil and not to allow the sale / distribution of Gutka, Panmasala by whatever name it is called in and around the premises of Colleges/canteens for effective enforcement of the prohibition in the state.

I am herewith enclosing IEC material to be distributed among the students on the health hazards of consuming gutka/Panmasala.

The following notification will be published in the Extra-ordinary issue of the Andhra Pradesh Gazette, dated17 -01-2013: -

The Government of India has promulgated integrated food law i.e., Food Safety and Standards Act 2006 (FSS Act) to regulate manufacture, storage, distribution, sale import so as to ensure availability of safe food for human consumption. FSS Regulations 2011 under the said act were notified which came into force from 5th August, 2011.

As per Regulation 2.3.4 of FSS (Prohibition and Restriction on sales) Regulations 2011, tobacco and nicotine shall not be used as ingredients in any food products.

Scientific studies reveal that Gutka, Pan Masala contain tobacco, nicotine as ingredients thus contravenes the Regulation 2.3.4 of Food Safety and Standards (Prohibition and Restriction on sales) Regulations 2011. Consumption of such products is injurious to health. Thus it is necessary to ban immediately.

As per Section 30 (2) (a) of FSS Act 2006, the Commissioner of Food Safety is empowered to impose prohibition in the interest of public health the manufacture, storage, distribution or sale of any article of food which is injurious to health in the whole state.1... Hence, it is expedient to prohibit the manufacture, storage, distribution, sale of gutka / panmasala in the state of Andhra Pradesh since it being food products in which tobacco and nicotine are widely used as ingredients.

NOTIFICATION

ORDER No. 1508/F1/2012-13: In exercise of the powers conferred under clause (a) of Sub-section (2) of section 30 of Food Safety and Standards Act 2006 read with 2.3.4 of Food Safety and Standards (Prohibition and Restriction on sales) Regulation 2011 and in the interest of public health, the Commissioner of Food Safety, Andhra Pradesh hereby prohibits the manufacture, storage, distribution, sale of Gutka / Panmasla by whatever name it is called which contains tobacco and nicotine as ingredients in the entire state of Andhra Pradesh for a period of one year with immediate effect.

Letter from the Commissioner Food Safety, A.P. Hyderabad, Lr.No.1508/F1/2012, Dated:05-10-2012 & 13-10-2012.

ORDER:

The Commissioner Food Safety, A.P. Hyderabad, in his letter read above has requested the Government to permit him to impose prohibition (ban) on sale of Gutkha / Pan Masala and other chewable products containing Tobacco and Nicotine in the State of Andhra Pradesh under section 30 (2) (a) of Food Safety and Standards Act, 2006.

2. Under regulation 2.3.4 of the Food Safety and Standards (Prohibition and restriction on Sales) Regulations, 2011 made by the Food Safety and Standards Authority of India in exercise of the powers conferred by clause (1) of subsection (2) of section 92 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006) with section 26 thereof, prohibits articles of food in which tobacco and/or nicotine are used as ingredients, as they are injurious to health.

3. AND WHEREAS, Gutkha, Paan masala containing tobacco and/or nicotine, other form of chewable products containing tobacco or nicotine (by whatsoever name) is an article of food in which tobacco and/or nicotine are widely used as ingredients.

4. AND WHEREAS, it is expedient to prohibit the manufacture, the storage, the sale, the transportation, the display or the distribution of Gutkha and Paan Masala containing tobacco and/or nicotine in the state of Andhra Pradesh.

5. The Government after careful examination hereby permit the Commissioner of Food Safety, A.P. Hyderabad to issue the following notification in the interest of the Public Health.

DRAFT NOTIFICATION

In pursuance of regulation 2.3.4 of the Food Safety and Standards (Prohibition and Restriction on sales) Regulations, 2011 the manufacture, the storage, the sale, the transportation or the distribution of Gutkha by whatever name and Paan masala containing tobacco and/or nicotine as ingredients by whatsoever name it is available in the market, is hereby prohibited with immediate effect in the State of Andhra Pradesh in the interest of Public Health until further orders.

6. The assistance of following Departments shall be taken for effective enforcement of above prohibition orders;

- a) HM&FW Department
- b) Vigilance and Enforcement Department
- c) Commercial Taxes, Department
- d) Police Department
- e) Transport Department
- f) Labour department,
- g) Municipal Administration Department
- h) Panchayat Raj Department

7. The Information and Public Relations Department and Commissioner, Civil Supplies and Consumer affairs shall give wide publicity and create consumer awareness. The enforcement personnel of FSS Act., shall be placed on regular basis at the inter-state check posts, to have vigil on the illegal transportation of the Prohibited articles into the State from other States. The Commercial Tax Department shall check the banned items and inform the enforcement authorities of Food Safety for taking necessary action.

8. The Commissioner of Food Safety, A.P. Hyderabad shall take necessary action accordingly.
