ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, in the wake of the outbreak of Corona Virus(COVID-19) which is declared as pandemic by World Health Organization, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

AND WHEREAS, the COVID-19 pandemic has brought to the fore the importance of Hygiene and Cleanliness in both personal as well as public spheres and that it is of utmost need to impose restrictions on unhealthy practices that may potentially lead to spread of such viruses and other infections.

AND WHEREAS, spiting of paan/any chewable tobacco or non tobacco product sputum etc., and the habit of PUBLIC SPITTING poses a serious threat to the spread of such infections such as Covid

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, SALONI RAI, IAS, District Magistrate, Diu in the interest of Public Health Safety hereby orders that the SPITTING OF PAAN/ANY CHEWABLE TOBOCCO OR NON TOBACCO PRODUCT, SPUTUM ETC., in Public Places and Institutions is hereby BANNED with immediate effect.

This order shall come into force immediately from the date of issue and shall remain in force till 3rd May, 2020.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.
