MEMORANDUM

Whereas, the Cigarette and Other Tobacco Products Act, 2003 was enacted in 2003 essentially to discourage the consumption of cigarettes and other tobacco products and to protect the youth and the general population from the harmful effects of tobacco use.

And whereas, Section 1 and Section 6 of COTPA prohibits smoking in public places which includes Schools, Colleges, Health Facilities, Municipal Offices along with other workplaces and lines.

And whereas, South Dum Dum Municipality, which is committed to the strict implementation of tobacco control legislation under its jurisdiction, aims to ensure that all facilities like offices, health centers, Educational Institutes and Parks located within its territorial jurisdiction are tobacco free.

Now, therefore, it is hereby ordered that -

- 1. "No Smoking" signage be prominently displayed at the entrance, and, additionally at every entrance, every floor and in other conspicuous places within the facilities mentioned above.
- 2. "Tobacco free educational institution" signage be prominently displayed at the main gate/outer boundary prohibiting the sale of tobacco products within 100 yards distance of any educational institutions.
- 3. The signages be in English, Bengali or in Hindi.
- 4. Steps be taken to ensure that nobody (teachers, staffs, students, patients and visitors) use any form of tobacco (smoking and smokeless) in the facilities mentioned above.
- 5. The name of the person to whom a complaint may be made be prominently displayed on the signage.
- Steps be taken to ensure that no smoking aids like ashtrays or lighters (used for smoking purpose) are present in the public places mentioned above.
- 7. Steps be taken to ensure that no tobacco products are being sold or offered in the whole campus of the public places including in the canteen, hostel, and mess and within 100 yards of the outer boundary/main gate of the educational institution.
- 8. Steps be taken to ensure random checking at the probable points of violation especially during the peak hours.
- The head of institution/office be the designated officer authorized to fine a person up to ₹ 200/- for violation of the provisions of the Act within the facilities mentioned above.
- 10. Steps be taken to ensure that complying with the law and making a public place- a "Smoke free Public Place" or "Tobacco Free Educational Institute" is a specific responsibility of the concerned head of institution/office.

This order will come into effect immediately.
