It is to submit that, TOBACO is the foremost preventable cause of death and disease in the world today, kindly half of the people who use it, it kills nearly 6 million people of those 0.6 million premature deaths can be attributed to exposure to second hand smoke (SHS).

It is submitted that, in 2003 the central Government passed the cigarettes and other Tobacco products Act (COTPA) applicable to all tobacco products. It has also taken steps to notify the law at the central and state levels Govt of India has given orders to form state Tobacco control cell and District Tobacco control in 2008.

State Tobacco control cell (STCC) has been implementing National Tobacco control programme (NTCP) from the O/o. Directorate of Public Health and Family Welfare, it is responsible for the overall planning implementation, and monitoring of different activities and at the same time the District Tobacco control cell (DTCC) shall establishment in a District under the umbrella of the District Health Society and it should constitute the following committees under the chairmanship of District Collector & Magistrate.


