PROHIBITORY ORDER

Whereas, Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (COTPA) is in force.

And Whereas, COTPA Enforcement Committee and Flying Squad have been formed in respect of Papum Pare District.

Now Therefore, it is hereby prohibited as follows:-

Smoking in the public places like hotel, restaurant, hospital buildings, educational institutions, public offices, court buildings, public conveyances, open spaces visited by public such as - bus stops, markets, auditoriums, stadiums, etc within Papum Pare District.

Selling of Tobacco products to any person who is under 18 years of age (minor), within Papum Pare District.

Sale, offer or permit sale of cigarette or any other tobacco products and display of tobacco products in an area within a radius of 100 yards of any educational institutions, within Papum Pare District.

It is further directed that :

A board saying "**No Smoking Area – Smoking here is an offence**" is prominently displayed at each entrance, floors, staircases, entrances of the lifts and at conspicuous place (s) onside by the Hotel/ in-charge/ proprietor/ manager of a public place. If the owner, manager, supervisor etc. fails to act upon any complaint he is liable to a fine equivalent to the number of individual offences recorded in his premises.

All the owners/ drivers of the Private Buses/ Public Transport vehicles are directed to display the board showing "**No Smoking- Smoking Here is an Offence**" in their vehicles.

The owner or the manager or the in charge of the affairs of a place where cigarettes and other tobacco products are sold, shall display a board of minimum 60 cm x 30 cm at conspicuous place(s) containing the warning "**Sale of tobacco products to a person under the age of 18 years is a punishable offence**".

The owner or manager or any person in –charge of affairs of the educational institutions within Papum Pare district shall display and exhibit a board at a conspicuous place (s) outside the premises, prominently stating that "**Sale of cigarettes and other tobacco products in an area within a radius of 100 yards of the educational institution is strictly prohibited which is an offence punishable under section 24 of the Act**"

The DDSE, Papum Pare District is hereby directed to ensure the same.

The COTPA Enforcement Committee and Flying Squads constituted in respect of Papum Pare are directed to conduct surprise checkings and take action as per COTPA Act 2003 against those who are found violating the **Act/Order**.
